



About DE-CONSPIRATOR

DE-CONSPIRATOR is a Horizon Europe-funded research project focused on combating Foreign Information Manipulation and Interference (FIMI). FIMI refers to tactics used by foreign actors to spread false information, create divisions, and erode trust in democratic institutions, all to advance their political or economic agendas at the cost of societal stability.

The project investigates how foreign actors, in particular Russia and China, manipulate, weaponise, and suppress information. By analysing their tactics and understanding what makes these campaigns effective through a transnational perspective, DE-CONSPIRATOR aims to build stronger defences against FIMI.

To achieve this, DE-CONSPIRATOR brings together a multidisciplinary team of top experts from thirteen organisations across Europe to decode FIMI. Together, they are developing innovative frameworks to safeguard information integrity and protect Europe's democratic values.

Investigating FIMI Tactics

Analysing how foreign actors, in particular Russia and China, design and execute FIMI campaigns to manipulate public opinion and destabilise democratic institutions.



Mapping FIMI Networks

Identifying and understanding the transnational networks that help spread FIMI across the EU and its Partner Countries, including their strategies and key domestic players.



Developing Innovative Tools

Creating advanced tools and methodologies, such as psychometric scales and a multilingual FIMI incidents database, to measure susceptibility to disinformation and assess its societal impact.



Engaging Communities

Conducting workshops and interviews to understand how individuals and institutions in Europe can strengthen their resilience against FIMI.



Promoting Collaboration

Bringing together researchers, policymakers, and cybersecurity experts to co-create strategies that protect information integrity and support democratic processes.
